## **Footnotes**

WAY STRIKING, urged to the fore along the rail in the opening stages, dictated terms on a narrow margin to the far turn, was prompted to extend the advantage nearing upper stretch, drifted out despite right handed pressure racing through the lane to turn back a challenge from MALIBU PRO and just held that rival on the wire. The latter was guided to the rail tracking just off the pacesetter racing as part of the second flight under light reserve, was prompted to advance while switching outside leader nearing upper stretch, moved to terms with that foe challenging for command, but was floated well wide in late stages while just failing to edge the leader. HIGH SECURITY gained terms with the leader prompting the pace racing to the far turn, shifted out four wide nearing midstretch but steadily weakened. PATRIOTS RULE settled last along the inside and passed tiring rivals late. RUFFOLO tracked the leaders three wide in second flight, angled to the inside leaving the far turn and steadily faded. ACES HIGH tracked the leaders between foes in second flight but was through after a half. FOLLOWING THE RACE THE RIDER OF MALIBU PRO LODGED A CLAIM OF FOUL AGAINST THE RIDER OF WAY STRIKING WHILE THE STEWARDS CONDUCTED A CONCURRENT INQUIRY. AFTER REVIEWING THE STRETCH RUN THE STEWARDS DISQUALIFIED WAY STRIKING FOR INTERFERENCE, PLACING HIM SECOND.
