

BLACK TAVISH set the pace early, shifted into the three path in the turn and faltered late in the stretch run. SNOW LEOPARD tracked the pace early, angled off the rail in the turn and weakened late in the stretch drive. GHOST IS CLEAR stalked the pace early, shifted into the four path in the turn and faded down the lane. PIERCE THE SKY was done early. SILVER STACKER was always outrun.
