SERGIOS PRIDE broke out at the start, chased the pace early, shifted into the four path in the turn, made a bid in the stretch but drifted out and hung in the late stages. WAR RANGER was well placed early, shifted into the three path in the turn, made a bid in the stretch but weakened late in the drive. CALL ME RED trailed the field early, swung into the six path in the turn and moved up in the stretch run. DUKE OF VISEU fanned into the five path in the turn and was empty late. OUTRAGEOUS JUSTICE was through after a half. BROOKLYN LEGEND improved position. MASHPEE POND had early speed then folded up. LOBI LOBI was done early. GENERAL LING had brief speed then retreated. TRY ARGUING HARDER came in at the start, shifted into the four path in the turn.
