MY RESTLESS HEART was fractious in the post parade and then was off slowly spotting the field several lengths, had a late rally in the stretch and was gaining but too late. LITTLEWAN was in a good stalking position in mid pack, had a mild late rally and some late gain. APRIL FLO showed good early speed, gave way and dropped back. RAE OF SUN failed to menace. BELLA SOUND was no threat. MIRADOR was off slowly and then never a factor.
