TEASE POINTS disputed the pace between horses, was unable to match strides with the winner but kept on well to clearly prove second best. GRIPEY SARAH settled in hand, came five wide and was along for the show. SUNSHINE CRUISE was allowed to settle, angled out entering the stretch and improved position through the drive. ZEND NERAH was unhurried into stride, ranged up six wide to make a mild bid but lacked the needed late response. ISO CITED broke in the air, dropped far back, finished with a belated gain but failed to threaten. OUR CAREER MOVE was forwardly placed along the inside to the stretch but lacked a response when called upon. DEVILISHLY WILD contested the pace along the inside to the stretch and retreated. EMPIRE PRINCESS failed to respond. LULU'SBACKINTOWN showed little. MIRADOR raced wide throughout and was outrun.
