CATNANDU tracked the pace two wide, took over leaving the second turn and quickly drew clear. DIXIE'S HOPE was rank to place behind rivals, veered in entering the first turn, settled into stride four wide, kept on well and clearly proved best of the rest. C. S. ROYCE settled toward the inside, checked hard off heels entering the first turn when DIXIE'S HOPE came in, settled into stride off of the inside, bid between horses and was along for the show. FLASHY'S SONG opened clear to set the pace, was collared leaving the second turn and gave way once headed. CATTOO was pinched back at the start, checked entering the first turn to avoid trouble, got through to make a late gain but lost her best chance. TALKIN AND SINGING was forwardly placed along the inside, weakened on the second turn and faded. SPEAK FREELY broke slowly, made a belated gain six wide but failed to threaten. SUNLIT was allowed to settle, steadied and swerved to the outside to avoid rivals entering the first turn, settled in the second turn and retreated. HOTTIE DANCER was forced wide entering the first turn and was never a factor. Following a jockey claim of foul and the Stewards inquiry DIXIE'S HOPE was disqualified from second and placed third.
