PERFECTLY MAJESTIC good position to the turn, rallied on wrong lead through the stretch, switched over late and went clear in the late going. CHRISTIANS CITY tracked from two path, took over into stretch but outfnshed and held the place spot. MURRY SPUR tracked four wide to far turn, two path into the stretch and held the show spot. ERNIE BANKS no speed to far turn, ducked in and out though the stretch run with no late gain. UNITE THE MASSES no speed to the far turn, moved up while no real threat. HIGH POWERED tracked three wide to far turn but used up and emptied out late. EVIL EYE never a menace. SEVENTY SEVENTYCAT always back. DERBY EXPRESS well placed never far back to the half and gave way from there. TEMPLE CITY STAR had an awkward start while no factor. CARISSIMO had an awkward start and never menaced. RED BLUE AND TRUE flashed inside speed to

the half but gave way readily. HEAD ON VIDEO NOT PROVIDED TO EQUIBASE.
