FILLYPINO rated off the pace inside, advanced along the rail through the final turn, angled to the three path entering the stretch, dueled to the lead near the sixteenth pole and inched away from there. POINT AFFIRMED rated with the pace inside, contested the final turn and remained a factor to the sixteenth pole before yielding the win, though held well for place. CATONTHEWIRE rated back inside, advanced to the heels of Fillypino at the three sixteenths pole, lacked room into the stretch then outfinished for place while closest to the rail. PEACE TIME rated off the pace inside, bid two deep into the final turn, swung out bothering Golden Cielo entering the stretch and flattened stride from there. GOLDEN CIELO rated off the pace about the four path, was forced out leaving the final turn and leveled off in the stretch. LYONNAISE rated off the pace inside and had no rally. FLYING TIGER, with the pace two deep, gave chase through the final turn and weakened in the lane. DIABLO'S DEVIL chased the early pace about the four path and faded on the backstretch. LOVIN COLLEEN was a step slow to break. The stewards disqualified Peace Time to fifth place after reviewing a claim of foul lodged by the rider of the fifth place finisher.
