Footnotes

CORDELE advanced four wide after three furlongs, bid outside rivals through midstretch, came in under right-handed pressure cutting off BAND OF ANGELS and forcing DELICIOUS PURSUIT into EILA, and drew clear. DELICIOUS PURSUIT raced in range three then two wide to the stretch, bid between horses through the furlong grounds, was forced in and taken up late, and regrouped to save second. LITTLE CHRISTINA hit the left side of the gate and bumped with STORM TEMPLE PILOT at the start, was outsprinted three to four wide around the turn, rallied outside and gained steadily to the finish. STORM TEMPLE PILOT bumped with LITTLE CHRISTINA at the start, steadied along the inside early on the turn, shifted to the two-path to the stretch, shifted out and was willing just inside LITTLE CHRISTINA late. EILA cleared off around the turn moving in to the two-path, settled into the stretch in command on the rail, and was yielding when forced to take up inside the first two finishers late. IT'S EASY TO SAY broke slowly, trailed three wide around the turn, and could not reach contention outside in the stretch. MALIBU STELLA was bumped by FALLEN LEAF at the start, outrun two wide into the stretch, and was taken up on the rail inside BAND OF ANGELS late. BAND OF ANGELS raced close-up from the outset, loomed a threat three wide through upper stretch, then clipped heels, stumbled and was taken up as CORDELE came over in front of her late. FALLEN LEAF broke out bumping MALIBU STELLA at the start, chased inside early and dropped back through the lane. FOLLOWING A STEWARDS INQUIRY, AS WELL AS CLAIMS OF FOUL BY THE RIDER OF DELICIOUS PURSUIT AGAINST CORDELE, BY THE RIDER OF EILA AGAINST DELICIOUS PURSUIT, AND BY THE RIDER OF BAND OF ANGELS AGAINST CORDELE AND DELICIOUS PURSUIT, CORDELE WAS DISQUALIFIED FROM FIRST AND PLACED EIGHTH FOR CAUSING

INTERFERENCE IN THE STRETCH.
