MY BELLE MICHELLE stalked the pace looming to upper stretch rallying up late four wide. BAREFOOT GYPSY pressured the pace wresting the lead on the turn, edged clear along the inside in upper stretch only to be run down at the end. PURPLE FLOWERS gave a hustled move to threaten four wide on the turn, bidding from mid track the final eighth would hang late. CUT RATES slow early lost ground to upper stretch outbidding the others seven wide. RANHANDLE JUSTICE slow early ran past tired ones to improve. RACHEL raced mid pack through the turn then weakened in upper stretch. SHELTOWEE'S GOLD rushed up five wide on the turn then flattened out in upper stretch. JEZABEL'S CHARM was never involved. SHELTOWEE'S POSSE had some early speed then gave way on the turn. CONJURING broke sharply to the early lead then stopped on the turn, was eased to the wire.
