SOLO DRINK raced back early on, was in the five path into the lane, made a bid three wide near the eighth pole, split horses near the sixteenth pole, edged clear and held off foe in the final stages. BIG IRON chased the pace early, took over and inched ahead near the quarter pole, was in the five path into the lane, continued the lead near the eighth pole while four wide, was under a long drive and fought back while gaining in the final stages. HIGH POWERED stalked the pace early from the inside, was in the three path into the lane, made a bid from between horses in the stretch but hung in the late stages. FRED'S COUNTRY BOY chased the pace early, was in the six path into the lane, made a bid five wide near the eighth pole but flattened out late in the drive. PURR CAT pressed the pace early, was off the rail into the lane, made a bid from the inside near the eighth pole but hung in the final stages. BARIN raced back early on, was in the four path into the lane and moved up in the stretch run. PIONEER DANCER chased the pace early, was in the three path into the lane and leveled off late in the stretch drive. FIGHTING FOR GRACE was never a factor. RESISTANCE JAK set the pace early very wide for a half then folded up. GUNNY ROO trailed the field throughout.
