**Footnotes**

NO WAY JOSE (IRE) secured inside position on the first turn then rated under slight restraint not far off the pacesetter, continued to save ground then angled out and picked up the pace late on the far turn, was set down three to four wide upper stretch, responded sharply and kicked clear. CARIBA stalked down the backstretch then moved up and took a slim lead at the quarter pole, continued to dig in with a narrow advantage at the furlong marker then could not hold off the challenge from the winner. HEIR OF LIGHT took over the lead in the first turn then set the pace to the far turn, got headed near the quarter pole but ran on and just lasted for a share. BERING STRAIT settled nicely while rated off the early pace, was ridden along two wide around the far turn,

came out wider under pressure, continued to steadily gain and just missed out on show. TAKE TEN raced off the pace and saved ground through the final turn then shifted out wide for the drive and improved position. TEMPLE CITY TERROR raced near the pace then put to a drove five wide entering the lane and passed tiring foes. MEMPHIS SHOWBOAT raced near midpack and had no kick when roused for response. ZABAVA raced off then pace then hustled along six wide into the lane but lacked a needed rally. SWEET HITCH HIKER steadied nearing the first turn, saved ground while not too far off the early pace but had no response when called upon. SERANITSA tracked between foes down the backstretch then urged along the inside on the far turn but failed to move on. PAKHET steadied nearing the first turn, raced off the pace and offered no late bid. ALL QUALITY tracked the pace to the far turn then weakened.
