TEENAGE KICKS raced inside early on, altered out three wide, took over command three wide nearing the lane, edged clear down the lane, came in under right handed whip inside the eighth pole and held sway in the final stages. ORB'S SOUL chased the pace early, was in the four path into the lane, made a bid down the lane but flattened out late in the drive. KISSES FOR HEIDI set the pace early, was on the inside into the lane, checked hard inside the eighth pole and weakened late in the drive. GOT A GOOD NOTION was a bit slow at the start, chased the pace early, was in the three path into the lane and moved up in the stretch run. LUMINAIRE pressed the pace early, was off the rail into the lane and faded late in the stretch drive. ACTRESS ON BOARD was through after a half. MRS. KIMBERLY K came out at the start and was done early. Along with a stewards inquiry, The rider of KISSES FOR HEIDI claimed an objection against the rider of TEENAGE KICKS for interference near the eighth pole and after review by the stewards, TEENAGE KICKS was disqualified and placed third for the infraction.
