CONJURING went to a clear lead, shook off a foe entering the stretch and drew auay. EDGE OF PLEASURE chased inside, angled out to the four path, gained on the leader around the turn, confronted that one entering the stretch but was no match. STORMY JUSTICE raced toward the back, took the turn from off the rail, came wide into the stretch and flew late, but too late for the place spot. HIGHLY VISIBLE raced at the rear, lost ground on the turn, and moved up on the rail down the lane. MS. MAXIMA steadied early on the backstretch, was unhurried, advanced on the turn in the two path but faltered in the final furlong. PRINCESS BROOKE chased the leader and backed up at the eighth pole.
