KATE'S GOLDEN DUDE off a bit slow inside, raced along evenly and leveled off to the wire. DILETTANTE good speed to the front, battled to deep stretch with not enough late. TREETOP FLYER off slow, no speed to turn, circled field quarter pole, moved up. SQUADRON COMMANDER tracked leaders to turn, no late response when needed. SMOLTZ never a factor while floating widest into stretch. BIG EXCHANGE could not keep up.
