Footnotes

FREE vied for the lead three wide into the turn, dropped closer to the inside when clearing for the lead just outside the three-eighths pole, slowly widened into the lane when moving closer to the rail and extended the advantage under a strong hand drive while skimming the rail the final eighth. DISCERNMENT was in the two path into the turn when never far back, chased the winner into the lane then was no match for that one while clearly second best. COMPETITIVE FIRE was in the two or three path through the turn, came into the lane from the three or four path then was under a drive while moving into the five path and never was a serious threat. GRACE D' ART vied for the early lead from between rivals into the turn then began losing ground. LUMINAIRE vied for the early lead while along the inside into the turn, chased the winner through the turn and faded. DON'T MAKE ME BEG was done early while in the three or four path.
