MOMENT challenged for the early advantage, dueled down the home stretch, brushed with rival and was outfinished. HIGH POWERED pressed the pace, eased back, saved ground around the second turn, made a late bid and was a clear third. HONORING MAJOR raced in the middle of the field, had an outside trip, made a bid and hung. OFF SIXES raced in the back of the pack in the beginning, improved position, but was no factor. POST CLOSE brushed at the start, raced within contention, finished wide and faded. GENTRIFIED void of early speed, raced outside around the final turn and was never close. TEMPRANO brushed at the start, raced near the back, lost contact with the field, was eased and walked off. THE JOCKEY OF #4 MOMENT LODGED A CLAIM OF FOUL AGAINST #1 REASON TO SOAR FOR INTERFERENCE DOWN THE HOME STRETCH. AFTER VIEWING REPLAYS STEWARDS TOOK NO ACTION.
