TELLER TO SING tracked three wide throughout, rallied at the top of the stretch, drew off late while racing in the four path under steady urging. HOMEROOM ANGEL was allowed to settle early, swung wide in the stretch and was just up for place. JAIL HOUSE CODE vied for the lead until mid stretch, then weakened. SHEISTHEHERO set the pace for three quarters, then faltered in the stretch. GOLDEN TEMPLE was unhurried early and was no threat. QUARANTINA saved ground and had no rally. DUDES LAWYER raced close up, early and was through after a half.
