R THREE ANGELS battled with the winner two wide, was bumped repeatedly in deep stretch and finished clear for second. RIGHT TRAPPE unhurried early, rallied outside rivals on the far turn then was outfinished. BLAZING ZENNA never far back, loomed boldly along the rail in upper stretch then came up empty. WINDY LU WHO stalked the pace for six furlongs then weakened. THE STEWARDS POSTED THE INQUIRY SIGN AND THE RIDER OF R THREE ANGELS LODGED A CLAIM OF FOUL AGAINST THE RIDER OF THE WINNER FOR INTERFERENCE THROUGH THE STRETCH. AFTER REVIEW THE STEWARDS DISQUALIFIED WEST SIDE GIRL AND PLACED HER SECOND.
